WHAT'S ON THE HORIZON

ORANGE COUNTY, NY PRIDES ITSELF ON ITS ECONOMIC DEVELOPMENT MODEL OF INNOVATION AND COLLABORATION. BECAUSE OF IT, GROWTH IS CONSTANTLY STIMULATED AND LOCAL BUSINESS OPPORTUNITIES HERE ARE CONSISTENTLY STRENGTHENED. THE FOLLOWING IS A SAMPLING OF OUR HORIZON OF INITIATIVES.

TOWN OF HAMPTONBURGH

Hudson Valley Crossing Corporate Park, located in the Town of Hamptonburgh, attracted diverse companies like Hunter Panels, McKesson and PharmaCannis because the necessary approvals were secured quickly without sacrificing environmental or quality-of-life concerns.

In collaboration with the Orange County Partnership, the Town recently extended the park's zoning overlay to permit industrial use for over 400 acres adjacent to Hudson Valley Crossing. This contiguous parcel will soon attain Shovel Ready status and will accommodate another slew of quality industrial end-users.

GO-SHEN!

Merlin Entertainments is moving swiftly through the approvals process with the Town of Goshen to construct a \$500 million LEGOLAND New York theme park that will include 50 rides and attractions and a 250-room LEGO-themed resort hotel. This will be LEGOLAND's third location in North America and their tenth worldwide. Also in the Town of Goshen, a \$95 million manufacturing plant for frozen food giant, Amy's Kitchen, is nearing its final approvals.

WHATS BEING BUILT

In the Town of Wawayanda, several hundred workers are building Competitive Power Ventures' \$900 million, 650 Megawatt natural gas-fired power plant.

MCKESSON

The nation's largest distributor of pharmaceuticals and medical devices and a Fortune 5 company, will complete the construction of their 340,000 square foot distribution center in the Town of Hamptonburgh. McKesson is currently

calibrating the hi-tech picking equipment for this distribution center that will employ more than 160 people.

ORANGE REGIONAL MEDICAL CENTER

ORMC, one of the newest hospitals in New York State recently opened its doors of their new \$99 million, 180,000 SF expansion in the Town of Wallkill. The new home of Greater Hudson Valley Health System Medical Group which serves Orange Regional Medical Center and Catskill Regional Medical Center.

ORANGE COUNTY GOVERNMENT

The county is currently renovating its Government Center in the Village of Goshen. The project, which includes an 86,000 square foot expansion, is expected to be completed by late 2017.

CRYSTAL RUN HEALTH

Orange County's local healthcare giant has opened a 70,000 square foot medical office building in the Village of Monroe, increasing their ever-growing presence in Orange County to five facilities and a total of over 2,000 employees in Orange County.

MATRIX DEVELOPMENT GROUP

Matrix is nearing completion of their massive 566,000 square foot distribution facility in the Town of Newburgh. Pharma giant AmerisourceBergen, a Fortune 12 company, will occupy over 300,000 feet while the remainder will be leased to Amscan, the party supply company who is expanding their existing footprint in Orange County.

UNITED STATES MILITARY ACADEMY AT WEST POINT

USMC is renovating and expanding its science building and constructing new barracks for cadets, at a cost of approximately \$500 million.

World-Renowned Woodbury Common Fuels OC Economy

Woodbury Common Premium Outlets, located in Central Valley, is one of the largest contiguous outlet centers in the world. Opened in 1985, the center underwent expansions in 1993 and 1998. It boasts 240 retail stores (all of which offer discounted prices) and occupies 900,000 square feet. The center is owned by Premium Outlets, a subsidiary of Simon Property Group, who also owns several other large notable developments.

Located one hour north of New York City, this charming Colonial American-style village center is a true showcase for the outlet industry with the country's largest collection of designer outlets.

Woodbury Common is nearing completion of their \$100 million expansion plan that

includes 60,000 square feet of additional retail space and improvements to traffic flow within the mall and the NYS Thruway interchange at Harriman and much more. This project has created 400 construction jobs and 350-400 permanent positions at the new stores.

The economic impact of Woodbury Common is staggering. It provides thousands of jobs, and, as a major NYS tourist attraction, brings 13 million visitors to the region annually.

And Woodbury Common isn't just a regional or even a U.S. attraction, as travelers from around the globe frequent the outlets seeking deep discounts on world-class brands. Tour buses and shuttles make daily trips from New York City. The

center employs a staff of interpreters, and currency exchange and foreign shipping services are available on site.
